THE LAVI CENTER

The LAVI Center provides care and support to victims of a criminal offence, as defined by the federal Law on Assistance to Victims of Crime (Loi fédérale sur l'aide aux victimes d'infractions LAVI), and to their relatives.

To be considered a victim under the LAVI, the persons must have suffered a criminal offence that has seriously affected their physical, psychological or sexual integrity, whether or not the perpetrator was discovered and whether he or she acted intentionally or through negligence.

Consultations are free and confidential.

Our intervention covers inter alia the legal, psychological and social fields.

We accompany the decision-making process while respecting the choices of our beneficiaries.

When the victim calls us, we listen carefully, and then fix an appointment for a consultation (also possible as an emergency if needed).

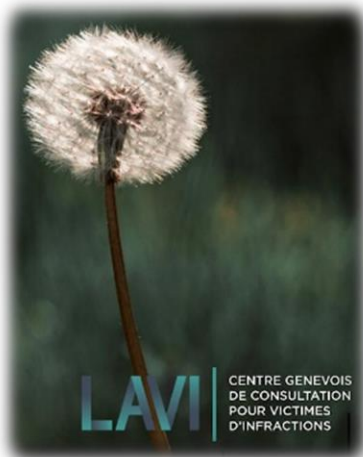

KIND OF SUPPORT OFFERED BY THE LAVI CENTER:

- **Information** on the LAVI law, the victim's rights, penal proceedings or any other step to be taken in relation with the offence (complaint or denunciation, social emergencies and emergency accommodation in shelters, insurance declarations, claims for compensation and reparation for moral harm, etc.);
- An **initial assistance** focused on the psychological consequences of an aggression and/or the violence suffered;
- Psychological, social and legal **support** and **follow-up** throughout the proceedings;
- **Referral** to professionals and specialized services: lawyers, psychotherapists, doctors, shelters, social services, associations, etc., and **collaboration** with the professional network, subject to the victim's formal agreement;
- If needed, **accompaniment** as a person of trust in the victim's dealings with the police and the courts, for the criminal proceedings or for the LAVI compensation board;
- **Financial assistance**, after evaluation and according to needs, covering costs directly related to the crime and not covered by the offender, insurance or other third parties, in accordance with the victim's financial situation and legal rates.



The LAVI Consultation Center is a private non-profit association. It is subsidized by the Canton of Geneva and supported by private donations.
